On 7/6/07, Detective Tim Dolan of the Stamford Police Department turned over to me a Dell Laptop computer for examination.

Det. Dolan requested the hard drive be searched for any information prior to 6/25/07 that pertained to information related to the murder of WWE wrestler Chris Benoit and his family. According to Det. Dolan, his agency was contacted by Georgia authorities that they had information that Stamford resident Matthew Greenburg had posted on the web about the murders 14 hours before the bodies were discovered. Det. Dolan had a consent to search form that was signed by Matthew Greenburg for the search of the computer.

An examination of the computers hard drive revealed no information that was posted about the homicide prior to June 25, 2007.


Det. Dolan was notified of the results, and the computer returned to him.
