Dear Dr. Beilenson:

In accordance with the powers and duties vested in the Secretary, Department of Health and Mental Hygiene (DHMH), responsibility for the enforcement of the regulations listed in Attachment A are hereby delegated to you, as the Health Officer for Baltimore City.

The Secretary retains authority to enforce the applicable statutes and regulations governing the public health and safety interests of the citizens of Maryland. Where, in the sole discretion of the Secretary, delegated programs are not adequately implemented locally, or for other reasons, the Secretary may revoke all or part of the delegated authority. The Secretary may also elect to take direct action to abate a public health or safety hazard or to assure conformance with applicable federal and State statutes and regulations where the local agency has not adequately addressed a problem or has not complied with Departmental policy.

This delegation of responsibilities under the purview of DHMH does not affect the delegation, if any, of responsibilities by the Secretary, Department of the Environment (MDE). The Baltimore City Health Department remains responsible for the enforcement of MDE regulations pertaining to water and sewage disposal within your jurisdiction in accordance with the current Memorandum of Understanding between DHMH and MDE.

I know you share my concerns for the health and safety of the citizens of Maryland and I trust that your staff will continue to work in partnership with the Office of Food Protection and Consumer Health Services.
