


THE LIST

This List includes the following information in five parts:

- (1) persons listed on the current version of the USA Swimming "Banned List" as a result of sexual misconduct in any form;
- (2) persons listed on the current version of the USA Swimming "Banned List" as a result of other misconduct;
- (3) US residents associated with swimming not listed on the current version of the USA Swimming "Banned List" but who have been arrested for or who are accused by a police body of sexual misconduct in any form;
- (4) international swimming coaches that have been banned by their NGB or who have been convicted of serious crimes; and
- (5) persons who have been publicly accused (by way of published media and by an identifiable accuser) of sexual abuse or misconduct.

Internet citations to media sources and archived documents are included on The List. The author of The List has relied upon the cited documents and has used these documents as justification for inclusion of all persons on The List.


Disclaimer: The author of The List cannot affirm or deny the truth of any accusation of sexual abuse made by an accuser against persons in part (5) of the List where there has been no criminal, civil, or administrative decision regarding the claim. All persons on The List who have merely been accused of any crime are presumed innocent until proven otherwise in a court of law or through an administrative body that provides reasonable due process.
