In support of a request for the issuance of an ARREST WARRANT for:

Willard Ross Colebank Jr, DOB: 07/22/1952, a 55 year old white male, height 6'00," weight 210 pounds, gray hair, hazel eyes, holding Social Security number 212-56-2600, possessing State of Colorado driver's license 95-007-0659

I, Detective Thomas B. Kinney, #4350, am a certified Police Officer with the Woodland Park Police Department. Your affiant states the following facts from which there is probable cause to believe that the crimes of:

18-06-403(2) (b.5), Sexual Exploitation of A Child, a Class 6 Felony (17 Counts)

were committed by the defendant on the 28th day of October 2007, as stated by the following facts, to-wit:

All information contained in this affidavit can be found in Woodland Park Police Department Case Report Number 07-1094.

On October 30, 2007 Deborah Colebank, wife of Willard Colebank Jr came into the Woodland Park Police Operations Center and spoke with Officer Dave Wagner. Deborah Colebank at that time gave Officer Wagner a bag full of CD's she said her son, Jeffrey Colebank found in the trunk of one of the family vehicles when it was parked at the family residence located at 131 Golden Court, City of Woodland Park, County of Teller, State of Colorado on Sunday, October 28, 2007.

Deborah Colebank identified the family vehicle that the CDs where found in as a 2003 Hyundai Santa Fe that Willard Colebank Jr operates. Deborah Colebank explained that Willard Colebank Jr is an alcoholic so they always check his vehicle for alcoholic beverages he may be attempting to hide. Deborah Colebank told me on November 1, 2007 she believed the last time either Jeffrey or she checked Willard Colebank Jr's vehicle for hidden alcoholic beverages would have been at least a month or two ago.

Deborah Colebank explained to me on Wednesday, October 31, 2007 that the CDs were found in a CD case that was stored in the spare tire storage area in the vehicle's trunk. Deborah Colebank said the CDs were assorted, with CD's that had no identifying labels to ones with photographic covers on them.

Deborah Colebank told Officer Wagner she had reviewed some of the computer files on the CDs that she had given him. Deborah Colebank said in the computer files she

reviewed she noticed they depicted males engaging in sexual acts, however she did not know the age of the males. Deborah Colebank explained she was worried because Willard Colebank Jr is a 7th and 8th grade teacher at Carmel Middle School, Harrison School District 2 in Colorado Springs.

Deborah Colebank told Officer Wagner that Jeffrey and she stayed in Grand Junction, CO for Jeffrey's band recital on Monday, October 29, 2007. Deborah Colebank told Officer Wagner on October 29, 2007 at 6:15 a.m., 6:35 a.m., and 5:30 p.m. Willard Colebank Jr telephoned her. Deborah Colebank told Officer Wagner that Willard Colebank Jr in those telephone conversations asked her where his "stuff" was after he had discovered the CDs missing, in what she said was an attempt to try to find out where the CD's were. Deborah Colebank said Willard Colebank Jr was very careful in his conversations with her as to not identify the missing "stuff" as being the CDs. Deborah Colebank told Officer Wagner that she confronted Willard Colebank Jr about the CDs and told him that he needed to resign from his teaching position. Deborah Colebank said William Colebank Jr told her she had ruined his life. Deborah Colebank told Officer Wagner that Willard Colebank Jr told her in the last telephone conversation she had with him that he was in Utah or Kansas, or two other states (she could not remember there names) and that she had taken his life that morning.

Deborah Colebank told Officer Wagner when she arrived home on Tuesday, October 30, 2007 she discovered Willard Colebank Jr had packed some of his clothes and toiletry items and was gone from the family home. Deborah Colebank told me that the family home, located at 131Golden Ct in Woodland Park, is where Willard Colebank Jr lived with her and their son until she discovered that he had packed up and left.

Deborah Colebank said she spoke to Mike Miles, Superintendent Harrison School District 2 on October 30, 2007 about Willard Colebank Jr and the CDs. Deborah Colebank told Officer Wagner that Mike Miles told her he was going to place Willard Colebank Jr on suspension until this case was sorted out. Deborah Colebank said she later learned from Mike Miles that when he called Willard Colebank Jr to his office to place him on suspension that Willard Colebank Jr had fled.

On October 30, 2007 Officer Wagner and Sergeant Ritchie obtained a search waiver from Deborah Colebank for a office area located in the family home, which Deborah Colebank said was mutually used by Willard Colebank Jr, Jeffery Colebank, and she. Officers did seize several CDs that were of the same brands given to them by Deborah Colebank. Also seized were a computer, four zip drives, and one thumb drive. Officers searched other area of the home but found nothing of evidentiary value.

Officer Wagner wrote in his report that he reviewed some of the CDs given to him by Deborah Colebank and said in his opinion they contained computer video files depicting what he believe to be children, at least six years old and older engaging in explicit sexual acts.

Sergeant Keith Ritchie who assisted Officer Wagner with the case investigation wrote in his report that Officer Wagner and he reviewed the CDs briefly for their content. Sergeant Ritchie wrote after his review of the CDs it appeared to him that all the CDs, but five were homemade. Sergeant Ritchie wrote in his review of the CDs the computer files contained video clips and web cam recordings of persons, mostly males, performing sexual acts on themselves and other males. Some of the clips showed males and females, who appear to be in their mid to late teens, involved in these acts. Others showed young adolescent males approximately 10-14 years old performing oral sex on one another and masturbating one another or themselves.

On Wednesday, October 31, 2007 I met with Adam Romine, a Colorado Springs Police Department Detective assigned to the Internet Crimes Against Children (ICAC) Task Force. Detective Romine and I reviewed some of the computer files containing on the CDs recovered from either Deborah Colebank or from the search waiver and in our opinions seventeen computer files contained sexually exploitation material, in that they showed juvenile males engaging in sexual intercourse or masturbating themselves. One of the computer files viewed titled "PEDO Danish Underage Kids" has been positively identified as being juvenile males engaging in sexual intercourse and is recognized as part of the "R@Gold" video series.

On Wednesday, October 31, 2007 I had a telephone conversation with Willard Colebank Jr when he telephoned me at the Woodland Park Police Operations Center to advise me that he would be coming to the Woodland Park Police Operations Center to see me that afternoon. In that telephone conversation Willard Colebank said he was tidying up some affairs for his wife so she did not have to come see him in jail. I asked Willard Colebank Jr why he believed he would be in jail and he told me, "Yeah well I don't know. I know what you have and when I come talk to you."

On Thursday, November 1, 2007 I spoke with Mike Miles on the telephone. I told Mike Miles that I had been told that Willard Colebank Jr may have made some admissions to him when he met with Willard Colebank Jr on Wednesday, October 31, 2007. Mike Miles told me on October 30, 2007 when he met with Willard Colebank Jr in an effort to determine if the information told him by Deborah Colebank was creditable and in an effort to make a determination regarding the safety of children he has asked Willard Colebank Jr about the CDs and DVDs that Deborah Colebank said where found in his (Willard Colebank Jr's) vehicle. Mike Miles told me this conversation was witnessed by Deloris Mullins, the HR Director for Harrison School District #2. Mike Miles said Willard Colebank Jr admitted to him that he had purchased some of the CDs and DVDs from an Internet website and others from an adult book store. Mike Miles said Willard Colebank Jr told him in responding to his question about the CDs and DVDs that in all likelihood some of the images the CDs and DVDs contained were of images of individuals under the age of eighteen.

Based on the facts in this your affidavit, Detective Thomas Kinney, respectfully request that an Arrest Warrant be issued for the arrest of Willard Ross Colebank Jr, DOB: 07/22/1952, a 55 year old white male, height 6'00," weight 210 pounds, gray hair, hazel eyes, holding Social Security number 212-56-2600, possessing State of Colorado driver's license 95-007-0659 on the charge(s) of CRS 18-06-403(2)(b.5), Sexual Exploitation of A Child, a Class 6 Felony (17 Counts).
