Please submit **CERTIFIED COPIES** [photocopies are not acceptable and will be rejected] of the following documents:

If you have ever been arrested, cited, charged, indicated, convicted, fined or imprisoned for breaking or violating any law or ordinance, excluding simple, minor traffic regulations (i.e. speeding or parking tickets), even if you entered a pre-trial diversion program, the charges were dropped, dismissed, you received a "no prosecution" or "no information" letter, you were pardoned, or the record was sealed or expunged, or the court issued an adjudication withheld or deferred judgment, you must provide for each and every incident the following documents:

- ALL arrests, charges or incident report(s) made by the arresting or other officer(s) for violation of any law in the United States and in ANY foreign country, at any time in your life
- The information or indictment and the judicial court judgment and sentence, including ALL probation orders and evidence of completion of all probation, and evidence of completion of any Court ordered fines, community service, counseling or any other sentence. - If you claim there is no record, you must submit verification by obtaining a statement, on official government letterhead stationery, certified by the clerk of court, from both the felony & misdemeanor divisions, and also from BOTH the police department and sheriff's office in the county of the arrest certifying that no records exist.
- If unobtainable, sealed records must be re-opened. Also, you must submit an original, certified letter on official government letterhead from both the police and sheriff verifying that there are no existing records of any violation of law.

You may wish to show a copy of this letter to the appropriate authorities to obtain the correct documents.

Submit ALL checked items with this letter within 30 days of the date of this letter. Failure to submit the above requested documents may result in DENIAL of your application.
