At 1340 hrs on 2/19/04 a taped statement was taken from _____ who gave the following account of the incident. _____ stated that Pussieldi was _____ legal guardian between 2000 and 2002 and also one of _____ swim coaches at the swimming Hall of Fame. _____ advised that _____ and Pussieldi were involved in a physical confrontation at the Swimming Hall of Fame on 2/13/04. _____ stated that Pussieldi had pulled him out of the bleachers by a towel that was hanging around his neck (See Case # 04-18791). _____ stated he would now like to report a videotape that he had located in Pussieldi's bedroom. _____ stated that on the tape he observed Pussieldi having sex with teenage boys. _____ stated that _____ thought they were teenagers because they did not have facial hair. _____ also stated that _____ did not think the video was made in the United States because _____ did not recognize the surroundings in the video and they were speaking Portuguese. _____ said that _____ saw three different boys on the tape, having sex with Pussieldi at different times. _____ also advised of a second videotape that showed him and his roommate _____ using the bathroom and getting undressed to take a shower. _____ stated that _____ did not know _____ was being filmed and it was done with a hidden camera, which _____ found in the bathroom in the air conditioning vent. _____ stated that _____ removed the batteries from the camera and scratched the lense so it would not work. _____ also stated that _____ had told _____ girlfriends parents (Ken Lucas) about the camera and they had confronted Pussieldi, and Pussieldi had admitted everything to them. **SEE STATEMENT FOR EXACT WORDING.**

On 3/22/04 I spoke with _____ by phone. _____ advised that when _____ was eighteen there was an incident between _____ and Pussieldi, were Pussieldi had touched _____ inappropriately. _____ told _____ that _____ did not want to pursue criminal charges when the incident had occurred. I asked _____ if _____ had ever seen any cameras when _____ lived with Pussieldi or if _____ had ever mentioned cameras or finding videotapes. _____ stated no that _____ didn't see any cameras nor did _____ remember telling _____ about finding any videotapes or cameras.

On 3/22/04 I spoke with Ken Lucas and asked if _____ remembered any type of incident that had occurred between _____ and Pussieldi. _____ told me all _____ knew is what _____ daughter had told him about the incident. I asked _____ if he had spoke to Pussieldi concerning the incident and _____ stated no.

At 1006 hrs on 4/08/04 a taped statement was taken from Pussieldi, who stated the following. Pussieldi stated that _____ had caused a disturbance at the pool while _____ was trying to instruct the other

Pussieldi then asked him to leave the pool. _____ again refused and started throwing things into the pool disrupting the other swimmers. Pussieldi then grabbed the towel around _____ and pulled _____ out of the bleachers. _____ then left the facility without further incident. I asked Pussieldi if he was aware of the other allegations _____ had made. _____ stated yes he was. He stated that at no time were there cameras in his home, nor did he have any VCR tapes containing him having sex with other people. I asked why he thought _____ had made these allegations. He stated that _____ had lived with him and _____ for approximately a year and half, and thinks that _____ was jealous of the relationship that he and Martins had. Pussieldi stated that _____ had told him that he would make sure that Pussieldi never coached again. I asked Pussieldi who is currently living with him. He stated that he has two swimmers living with him; the youngest is twenty-two years old. **SEE STATEMENT FOR EXACT WORDING.**
